## 1. PURPOSE

1.1. This policy sets out how The Waldorf School treats information that is received and/or collected from visitors to the school's website.

## 2. SCOPE

2.1. This policy applies to all visitors to The Waldorf School's website.

## 3. POLICY STATEMENT AND PRINCIPLES

3.1. The Waldorf School is committed to treating all information that received and/or collected from visitors to our website with the strictest confidentiality.

3.2. The Waldorf School will not sell any information gathered to any third party.

3.3. The Waldorf School will not share information gathered except when required to do so by law.

## 4. PRIVACY POLICY

4.1. We collect certain information or data about visitors when they use our website. This includes:

4.1.1. questions, queries or feedback, including IP addresses and browser version when messages are sent via a form on our website.

4.1.2. IP addresses from which our website are accessed, and details of which version of web browser and operating system were used by visitors.

4.1.3. the date and time of a visit.

4.1.4. Google Analytics data, which is information on how visitors use our website, using cookies and page tagging techniques to help us improve our website. By using this website, you consent to our use of cookies.

4.1.5. the website address of the website from which visitors accessed our website.

4.1.6. the approximate location from which visitors viewed our website.

4.2. This helps us to:


4.2.1. improve our website by monitoring how visitors use it.

4.2.2. respond to any feedback visitors send us, if requested.

4.2.3. Unless visitors voluntarily submit personal information to The Waldorf School (for example, by sending an email or completing the contact form), a visitor can't be personally identified using their data.

4.3. Data Storage

4.3.1. We respect visitors' right to privacy and are committed to ensuring that their information is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect.



4.3.2. Although we take reasonable steps to safeguard information, we cannot be responsible for the acts of those who gain unauthorised access. We make no warranty, express, implied or otherwise, that we can prevent such access.

4.3.3. We won't share information with any other organisations for marketing, market research or commercial purposes, and we don't pass on visitors' details to other websites. We may pass on personal information if we have a legal obligation to do so, or if we must enforce or apply our terms of use and other agreements.

4.3.4. When visitors submit any personal data, they agree to 4.3.1. - 4.3.3.

#### 4.4. Other websites

4.4.1. Our website may contain links to and from other websites. This privacy policy only applies to our website.

4.4.2. If visitors go to another website from this one, including any websites that we link to, they should read the privacy policy on that website to find out what it does with their information.

4.4.3. If visitors come to our website from another website, we may receive personal information about the visitor from the other website. Visitors should read the privacy policy of the website they came from to find out more about this.

### 5. REVIEW

5.1. The Waldorf School may update this privacy policy from time to time by posting the latest version on our website. Visitors should check this page occasionally to ensure that they are informed of any changes.
